BEER HEARING #1

On May 10, 2014 Mayor Burriss opened a Beer Hearing for Keith Everett Kirby for the purpose of selling beer at 529 North College Street, Trenton, TN 38382. Those present for the meeting were Mayor Burriss, Aldermen Gibson, Hammonds, Jackson, Wade, Abbott and Overall. City employees present were City Recorder Leigh Reynolds, Richard Gossum, Terry Bailey, Ricky Bailey, Terry Brown, Chief Barry Green, Chief Will Sanders, and Scott Dahlstrom. Visitors present were William Lowery, Teresa Lowery, Margaret Doss, Glynn Doss, Keith Kirby, Michael Poteet, Lanny Poteet and Myra Elam. Mayor Burriss asked for any comments. Chief Sanders was asked about the background check and he stated it was fine.

The Beer Hearing was adjourned at 6:02pm.

Alderman Gibson made a motion to allow the sale of beer at 529 North College Street, Trenton, TN. to Keith Everett Kirby. Alderman Wade seconded the motion. The motion carried by Aldermen Gibson, Jackson, Abbott and Wade voting yea and Alderman Hammonds and Overall nay.

BEER HEARING #2

Mayor Burriss opened the second Beer Hearing for Margaret Ann Doss for the purpose of selling beer at The River on North College Street, Trenton, TN 38382. Mayor Burriss asked for any comments pro or con and there were none. Chief Sanders was asked about the background check and he stated it was fine.

The Beer Hearing adjourned at 6:04pm.

Alderman Wade made a motion to approve the sale of beer to Margaret Ann Doss at The River on North College Street, Trenton, TN. Alderman Jackson seconded

the motion. The motion carried by Aldermen Gibson, Jackson, Wade and Abbott voting yea and Alderman Hammonds and Overall nay.

COUNCIL MEETING

Mayor Burriss called the regularly scheduled meeting of the Trenton City Council to order. Alderman Gibson led the invocation with the Pledge of Allegiance to follow. Those present for the Beer Hearing were there for the council meeting.

Alderman Jackson made a motion to adopt the minutes of the May 27, 2014 council meeting as distributed. Alderman Hammonds seconded the motion. The motion carried by voice vote.

RECORDER'S REPORT

City Recorder Leigh Reynolds reported the expenditures for the month. Alderman Overall made a motion to pay the expenditures with the general fund expenses being \$44,400.40 and sanitation \$60,013.31. Alderman Hammonds seconded the motion. The motion carried by voice vote.

Trenton Light and Water has purposed an agreement with the City for Park maintenance on poles and fixtures for a month investment fee. TL&W have checked the condition of the poles and 6 out of 20 are in fair to poor condition.

Alderman Hammonds made a motion to accept the agreement with TL&W for maintenance on poles and fixtures for a monthly investment fee at the City Park. Alderman Abbott seconded the motion. The motion carried by voice vote.

CITIZEN'S INPUT

William Lowery with the Fair Association stated that this will be the 159th Gibson County Fair starting August 25, 2014 thru August 30, 2014.

NEW BUSINESS

1ST READING ORDINANCE #294 2014-2015 TRENTON CITY BUDGET

Alderman Wade made a motion to pass the 1st reading on Ordinance #294 for 2014-2015 Trenton City Budget with property tax rate at \$1.5870 per \$100. Alderman Gibson seconded the motion. The motion carried by voice vote.

ORDINANCE #289 TO AMEND SECTION 7-504 FIREWORKS

Alderman Hammonds made a motion to pass 1st reading on Ordinance #289 to amend section 7-504. (It is unlawful to explode or ignite fireworks except for the time periods set out in Section 7-501(6). Alderman Jackson seconded the motion. The motion carried by voice vote.

ORDINANCE #290 TO AMEND SECTION 8-211 (3) BEER CODE

Alderman Hammonds made a motion to pass 1st reading on Ordinance #290 to amend section 8-211 (3) Beer Code, changing expense for newspaper advertisement of public notice. Alderman Wade seconded the motion. The motion carried by voice vote.

ORDINANCE #291 TO ADD SECTION 11-404 DISORDERLY HOUSES

Alderman Hammonds made a motion to pass 1st reading on Ordinance #291 to add section 11-404 to disorderly houses. Alderman Overall seconded the motion. The motion carried by voice vote.

ORDINANCE #292 TO ADD SECTION 11-403 LOITERING

Alderman Jackson made a motion to pass 1st reading on Ordinance #292 adding section 11-403 to loitering. Alderman Hammonds seconded the motion. The motion carried by voice vote.

ORDINANCE #293 TO ADD SECTION 11-405 INDECENT OR IMPROPER DRESS

Alderman Hammonds made a motion to pass 1st reading on Ordinance #293 adding section 11-405 indecent or improper dress. Alderman Wade seconded the motion. The motion carried by voice vote.

REPORTS FROM DEPARTMENT HEADS

TERRY BROWN/PARK DEPARTMENT

Terry stated that this weekend there will be a 2014 youth ball tournament with 24 teams participating and that he has had to remove belt and tire swings because of safety issues.

WILL SANDER/POLICE DEPARTMENT

Chief Sanders informed the council that the department had received 429 calls for service. Those calls are for a request to see a police officer. He also stated that the department is getting training for the E citation and will start using them next week.

SCOTT DAHLSTROM/LIGHT AND WATER DEPARTMENT

Scott stated that they will start installing water meters Friday and the outage Thursday night was a mess. They worked for 12 hours to restore service with the help of Union City and Milan.

ALDERMAN'S REPORT

Alderman Gibson thanked the budget committee for a good job on the budget. Alderman Hammonds enjoyed working with everyone on the budget committee and thanked TL&W for the hard work.

Alderman Abbott stated that Randy Bail with wrestling building is paying a sanitation fee but does not have a can.

Relay for Life will be Friday and Alderman Abbott would like to see everyone there.

Discussion of changing dates for the sale of fireworks.

ORDINANCE #295 TO AMEND CHAPTER 5, SECTION 7-501, ARTICLE 6

Alderman Abbott made a motion to pass 1st reading on Ordinance #295 to amend Chapter 5, section 7-501, article 6 to read; "Seasonal Retailer" means any person engaged in the business of making retail sales of fireworks within the City of Trenton, TN, from June 27 through July 4. Alderman Overall seconded the motion. The motion carried by five yeas and Alderman Hammonds nay.
