PUBLIC HEARING

Mayor Jackson opened the Public Hearing to rezone the property located at 305 Paradise Alley from R-3 to M-1. Hearing closed at 6:03pm.

Mayor Jackson called the regularly scheduled meeting of the Trenton City Council to order.
